## AMENDMENT NO. 5

## TO AGREEMENT FOR PROFESSIONAL SERVICES WITH STANTEC, INCORPORATED FOR THE DESIGN OF LAGUNA COUNTY SANITATION DISTRICT RECYCLED WATER DISTRIBUTION SYSTEM TO WALLER COUNTY PARK

THIS AMENDMENT, effective as of the date last written below, is entered into between the Laguna County Sanitation District, a dependent special district of the County of Santa Barbara, a political subdivision of the state (hereinafter DISTRICT) and Stantec, Incorporated, having its place of business at 2646 Santa Maria Way, Suite 107, Santa Maria, CA 93455 (hereinafter ENGINEER).

WHEREAS, the parties hereto, on May 9, 2017, entered into an agreement (BC18-125) for performance of professional services by ENGINEER in connection with the Laguna County Sanitation District Recycled Water Distribution System to Waller County Park; and

WHEREAS, the original agreement term is through June 30, 2018; and

WHEREAS, Amendment No. 1 in the amount of \$7,500 was executed by the Public Works Director on November 18, 2017 and provided for the preparation of display drawings for the Park Commission; and

WHEREAS, Amendment No. 2 in the amount of \$6,800 was executed by the Public Works Director on January 19, 2018 provided for the preparation of a planting plan at the tank site; and

WHEREAS, Amendment No. 3 was executed by the Board of Directors on June 19, 2018, which extended the term of the agreement to June 30, 2019; and

WHEREAS, Amendment No. 4 in the amount of \$9,000 was executed by the Public Works Director on December 10, 2018 provided for the preparation of legal descriptions for easements; and

WHEREAS, it is necessary and appropriate to extend the term of the Agreement in order to complete the work.

NOW THEREFORE, the parties hereto agree as follows:

- A. Paragraph 4, "Term" of the Agreement is hereby extended until June 30, 2020.
- B. Except as amended herein the Agreement shall remain in full force and effect.
