THIRD AMENDMENT Effective July 1, 2018

THIS IS THE THIRD AMENDMENT (hereafter referred to as Third Amendment) to the Agreement for STEMI Receiving Center Designation, by and between the County of Santa Barbara (COUNTY) and Santa Barbara Cottage Hospital (HOSPITAL) (the "Agreement").

WHEREAS, the Agreement is effective through June 30, 2018; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, this Third Amendment incorporates the terms and conditions set forth in the Agreement, First Amendment and Second Amendment, approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this Third Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. **Amendments.**

- a. The Agreement is amended as follows:
 - 4. <u>TERM.</u> The term of this Agreement shall be for the period of July 1, 2018 through June 30, 2019.
 - 5. <u>FEES.</u> HOSPITAL agrees to pay COUNTY for services provided under the terms of this Agreement: \$29,114.00 annually for maintaining the STEMI program. This annual service charge shall be paid in full by July 31, 2018.
- 3. <u>Counterparts.</u> This Third Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. **Effectiveness of Agreement**. Any and all other terms and provisions of the Agreement, as amended, remain in full force and effect.
