- B. WHEREAS Applicant is an approved state ESG Administrative Entity; and
- C. WHEREAS the Department may approve funding allocations for the ESG Program, subject to the terms and conditions of the NOFA, Program regulations and requirements, and the Standard Agreement and other contracts between Department and ESG grant recipients;

NOW THEREFORE BE IT RESOLVED THAT:

- 1. If Applicant receives a grant of ESG funds from the Department pursuant to the above referenced ESG NOFA, it represents and certifies that it will use all such funds in a manner consistent and in compliance with all applicable state and federal statutes, rules, regulations and laws, including without limitation all rules and laws regarding the ESG Program, as well as any and all contracts Applicant may have with Department.
- 2. Applicant is hereby authorized and directed to receive a ESG grant, in an amount not to exceed \$700,000 in accordance with all applicable rules and laws.
- 3. Applicant hereby agrees to use the ESG funds for eligible activities as approved by the Department and in accordance with all Program requirements, and other rules and laws, as well as in a manner consistent and in compliance with the Standard Agreement and other contracts between Applicant and Department.
- 4. The Community Services Director, or designee(s) in the event that sufficient evidence of designation is provided to the Department, are authorized to execute the Standard Agreement and any subsequent amendments or modifications thereto, as well as any other documents which
