That the service charges and connection charges fixed by Ordinance No. ______ and set out in said report, and each of them, be collected at the same time and in the same manner and by the same persons as, together with and not separate from the general taxes, for the Laguna County Sanitation District.

3. The Clerk of the Board is directed to file with the County Auditor-Controller, on or before August 10, 2019, a certified copy of this Resolution and the report, indicating adoption by the Board in accordance with Health and Safety Code Section 5473.4. Upon such filing, the County Auditor-Controller shall enter the charges on the tax roll for the 2019-2020 fiscal year. The charges shall be collected at the same time and in the same manner, and subject to the same penalties and priority of

lien as, County taxes are collected, and all laws providing for the collection and enforcement of County taxes shall apply to the collection and enforcement of the charges.
