That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the attached construction contract with Day Wireless Systems, for the Distributed Antenna System, Project 8600-DAS, for a contract amount of \$246,103.17;
- b) Authorize the Director of General Services or designee to approve change orders in an amount not to exceed \$24,610, as authorized under California Public Contract Code Section 20142; and

Summary Text:

Construction of the Northern Branch Jail is approximately 87% complete, and General Services is in the process of making procurement decisions relative to the furniture, fixtures and equipment (FF&E) required to operate the facility, the bulk of which is funded by the AB900 conditional award. One of the critical items required for the facility's operation, is the Distributed Antenna System (DAS) for the emergency responders' radio coverage in the Northern Branch Jail. General Services conducted a bid for the system in accordance with California Public Contract Code, and recommends awarding the contract to Day Wireless Systems, the lowest bidder.

The award of a contract to Day Wireless in the amount of \$246,103.17 will allow the DAS system to be implemented such that emergency responders will have the ability to use radios within the Northern Branch Jail as envisioned.

Background:

The County of Santa Barbara plans to utilize and register three frequencies with the Federal Communications Commission (FCC) as emergency responder radio coverage systems at the Northern Branch Jail. These are for fire dispatch, law dispatch, and corrections. Because the Northern Branch Jail is a steel and masonry building, frequencies are not easily transmitted throughout the building. Thus, the DAS will mitigate the disruption of frequencies in the building, and provide for radio coverage throughout the facility.

On January 23, 2019, General Services solicited bids for the DAS system, and on April 4, 2019, two (2) bids were opened, with Day Wireless Systems the lowest responsive bid in the amount of \$246,103.17.

Award of the contract to install the DAS is critical for emergency responder radio coverage throughout the Northern Branch Jail. The extensive conduit pathways and junction boxes required for the DAS was included in the Northern Branch Jail construction, and is ready for installation of the system.
