#### **Recommended Actions:**

That the Board of Directors:

- A. Designate the Laguna County Sanitation District chief plant operator to act as the duly authorized representative to sign and file all reports as required by the Regional Water Quality Control Board;
- B. Find that the proposed action does not constitute a "Project" within the meaning of the California Quality Act (CEQA), pursuant to 14 CCR 15378 (b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

# Summary Text:

This item is on agenda in order to designate the Laguna County Sanitation District chief plant operator as the duly authorized representative to sign and file all reports by the Regional Water Resources Control Board pursuant to the *State Standard Provisions and Reporting Requirements for Waste Discharge Requirements*.

# **Background:**

Pursuant to Section 3670 et seq. of Title 23 of the California Code of Regulations, all wastewater treatment facilities in the State of California are required to be operated by a certified operator at a grade appropriate for the class of plant being operated. The operator with overall responsibility for operation

including compliance with effluent limitations and ensuring that other operators are properly supervised is known as the chief plant operator as defined in Section 3671. The Laguna County Sanitation District wastewater reclamation plant is a Class IV facility (tertiary with design flow between 1 and 10 million gallons per day) and requires that the chief plant operator hold a Grade IV operator certification. The reclamation plant is regulated by the Central Coast Region of the California Regional Water Quality Control Board under *Waste Discharge Requirements and Master Recycling Permit Order No. R3-2011-0217*, which further references the *State Standard Provisions and Reporting Requirements for Waste Discharge Requirements Resolution No. R3-2013-0052* for general monitoring and reporting criteria. General Reporting Provision C.14 stipulates that for a public agency all reports shall be signed by either a principal executive officer or ranking elected official or a duly authorized representative. Historically, this activity has been performed by the chief plant operator and this action formally defines the duly authorized representative as the chief plant operator to comply with State Provisions.

This action names the most knowledgeable person as the party responsible for submitting reports to the Regional Water Quality Control Board.
