The Engineer is authorized to order, as additional change order work, payment for the final amounts for additional work to close the Contract for the Debris Processing Project in an amount not to exceed \$24,786.93 in accordance with California Public Contract Code Sections 20136 and 20137, as applicable, to be paid as provided in the Contract Documents.

2. The terms and provisions set forth in this Amendment No. 1 shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this Amendment No. 1, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
