Recommended Actions:

That the Board of Supervisors consider the following:

- a) Approve and authorize the Chair to execute a First Amendment to the Agreement with Anacomp, Inc. (BC-17272), to provide an internet archive system and convert a portion of historical Fire Department records from paper to digital format, increasing funding by \$26,500.00 for a total contract amount not to exceed \$113,000.00;
- b) Approve and authorize the Fire Chief or designee to approve a contingency for services with Anacomp, Inc. in the amount not to exceed \$5,166 for any additional services within the scope of work that may be required to complete the project;
- c) Find that the proposed Agreement is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline section 15378(b)(2) in that the Agreement involves a continuing administrative or maintenance activity, and CEQA Guidelines section 15378(b)(5), in that the Agreement involves an organizational or administrative activity of government that will not result in the direct or indirect physical change in the environment.

Summary Text:

This First Amendment is to increase the amount of the Agreement for digital conversion services.

Background:

On April 11, 2017, your Board approved the Agreement with Anacomp Inc. (Attachment B), in the amount of \$86,500.00 plus a contingency of \$2,517.00, for a total of \$89,017.00. The original agreement included an estimate of \$21,156.00 for cost reimbursement, training and digital conversion services. Total costs for the conversion services exceed the original approved funding. This First Amendment increases the funding for the set up and conversion services by \$26,500.00 and provides for a total contingency in the amount of \$5,166.00. The total contract amount will now be an amount not to exceed \$113,000.00 with a contingency not to exceed \$5,166.00.
