## Gentlemen:

I have been a resident of Santa Ynez Valley for nearly ten years. I am the owner of a vineyard, Rancho Rita Vista, and I am writing to express my support for your approval of the Conditional Use Permit to allow 25 events per year at Crossroads.

Over the past ten years, I have had the privilege and pleasure of attending numerous events at Crossroads. Moreover, as a former neighbor (my former ranch was located at the corner of Ballard Canyon Road and Highway 154), I am very familiar with the minimal effort these events had upon the area. Relative to their benefits to the community, the impact was negligible.

With local wineries entitled to 12 "for profit" events per year by right and up to 40 commercial events per year with a Conditional Use Permit, allowing Crossroads to provide the service that it has given this community is appropriate. This is a necessary venue for the community. It is unique and the organizations around the County have relied on Crossroads for years as a beautiful, rural setting where they can gather without adversely impacting neighbors. The roadways are more than adequate to handle the traffic and surrounding properties are either vineyard or large ranches. County requirements already limit the hours for the events and control noise levels.

With the existing vineyard on the property, agriculture will continue without interruption from the events. At an average rate of 2 events per month, agriculture remains the primary use of the property. The events simply supplement the owner's income enough to pay to keep up the improvements, while promoting the owner's wines. It's a win-win for the owner and for the community.

The past landowner and the current owner are generous to offer this venue to non-profits for their fundraisers. I do not know what many charatable groups would have done without Crossroads.
