Recommended Actions: That the Board of Supervisors

Consider recommendations regarding the American Recovery and Reinvestment Act (ARRA) Grant for the District Attorney's Office, as follows:

a) Authorize the District Attorney to accept and receive a Grant Award from Department of Justice - Violence Against Women Act (VAWA) Vertical Prosecution Recovery Act Program for the period July 1, 2009 through September 30, 2010 in the amount of \$207,232, along with \$69,077 in 25% required matching funds to serve victims of sexual assault and domestic violence.

Summary Text:

The American Recovery and Reinvestment Act (ARRA or Recovery Act), signed into law February 17, 2009, provides \$175 million in Violence Against Women - STOP formula funds to improve the criminal justice system's response to violent crimes against women. The Recovery Act was enacted to:

- preserve and create jobs;
- promote economic recovery;
- help people most impacted by the recession;
- increase economic efficiency by investing in technological advances in science and health;
- promote long-term economic benefits by investing in transportation, environmental protection and other infrastructure; and
- preserve essential services in states and local governments.

Funds are made available by ARRA through the California Emergency Management Agency (Cal-EMA) – Law Enforcement & Victim Services Division for grants to support local prosecution efforts and victim services provided by District Attorney Offices. Initially the Santa Barbara County DA applied for a \$150,000 + \$50,000 match grant to sustain three staff assigned half time to the North County Domestic Violence Vertical Prosecution Unit. While the initial application was not funded, new Vertical Prosecution Recovery Act Program Grant Funds in the amount of \$207,232 + \$69,077 match were awarded to this office for a 15 month grant. The vertical prosecution team will have a priority focus on cases involving victims of sexual assault, with felony domestic violence cases also assigned to the unit. An estimated 300 victims will be served, by providing criminal justice information, support and referral assistance to facilitate access to services and ensure victims' safety.

Background:

Historically, the District Attorney's Office has received State and Federal funds to support domestic violence vertical prosecution teams. Last fiscal year, \$70,000 in State Department of Justice Tunds were cut from the State budget, resulting in the loss of an attorney position in South County. A total of \$150.000 in Federal VAWA funds ± a \$50,000 match were included in the budget to sustain three staff assigned to the domestic violence vertical prosecution unit in North County. The revised allocation, administered by Cal EMA, will sustain staffing for 15 months, with a primary focus on adult victims of sexual assault and secondarily, felony victims of domestic.

Performance Measure:

- Prosecute an estimated 200 violent crimes against adult women.
- Provide 300 victims with criminal justice information, support and referral assistance to ensure victim safety and access to services

The federal grant funds and match are included in the District Attorney's Adopted budget 021/1001/7000.
