Recommended Actions:

That the Board of Supervisors:

- (a) Approve and authorize the Chair to execute an Agreement for Professional Legal Services between the County of Santa Barbara and Rutan & Tucker, LLP, in an amount not to exceed \$200,000, for a term ending July 25, 2021; and
- (b) Determine that the above action is not a project under the California Environmental quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(b)(4) and 15378(b)(5) because it consists of government administrative or fiscal activities that will not result in direct or indirect physical changes in the environment.

Summary Text:

The Board of Supervisors, under the provisions of Section 31000 of the California Government Code, is empowered to contract for special legal services. County Counsel recommends the assistance of outside counsel Rutan & Tucker, LLP to provide legal advice and litigation services regarding public construction projects.

Fiscal and Facilities Impacts:

This contract is budgeted and the Litigation fund balance component of the General Fund will be used to pay for the costs of this contract.
