ORDER TO VACATE A COUNTY ROAD

PORTIONS OF PUBLIC RIGHT-OF-WAY ADJACENT TO APN 135-102-010 AND APN 135-102-008 LOS OLIVOS, CA

WHEREAS, the County of Santa Barbara (hereinafter "COUNTY") is the owner of those certain road properties in the unincorporated area of the County of Santa Barbara, State of California, in the Town of Los Olivos (collectively "Road"), which Road was acquired in easement interest by COUNTY pursuant to the Map of the Town of Los Olivos, filed in Rack 3, Map No. 6; and

WHEREAS, the portions of right-of-way proposed for summary vacation (herein the "Portions") total approximately 1,000 square feet and are situated adjacent to County Assessor's Parcel Number (APN) 135-102-010 and APN 135-102-008 (herein the "Properties"). Portions are legally described and shown on Exhibits "A" and "B"; and Exhibit "C" attached hereto and incorporated herein by this reference; and

WHEREAS, the owners of the Properties submitted an application to the COUNTY to vacate the Portions; and

WHEREAS, the proposed rights-of-way summary vacation would dispose of COUNTY road rights-of-way by permanently removing the COUNTY'S easement interest in the Portions; and

WHEREAS, at its regular meeting of January 30, 2019, the COUNTY'S Planning Commission found the abandonment of the COUNTY'S rights-of-way to be in conformity with the COUNTY'S Comprehensive Plan pursuant to Government Code Section 65402(a); and

WHEREAS, it has been determined by COUNTY'S Public Works Department that, in accordance with Section 892(a) of the California Streets and Highways Code, the Portions are not useful as a bicycle path or route; and

WHEREAS, it has been determined by the COUNTY'S Public Works Department that the Portions are unnecessary for present or future public use as portions of county roads and are no longer required by the traveling public or the COUNTY; and

WHEREAS, no parcels will be landlocked if the Portions are vacated; and

WHEREAS, a private ingress and egress easement shall be reserved and excepted from the summary vacation of the Portions for the benefit of owners of APN 135-102-010 and APN 135-102-008; and

WHEREAS, an easement shall be reserved and excepted from the summary vacation of the portions for Fire Department and emergency response access in the event of any emergency event or when County Fire may require access to reach neighboring properties; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of COUNTY does hereby find, determine and order as follows:

- 1. That the above recitals are true and correct.
- 2. That the Portions being vacated are unnecessary for present or prospective public use.
- 3. That the Portions being vacated are excess right-of-way of a street not required for street or highway purposes.
- 4. That the Portions, consisting of portions of the right-of-way located in the alley between Jonata Street and Alamo Pintado, are situated adjacent to County

Assessor's Parcel Number (APN) 135-102-010 and APN 135-102-008 and are legally described and shown on Exhibits "A" and "B"; and Exhibit "C" attached hereto and incorporated herein by this reference, are hereby vacated as a County road pursuant to Division 9, Part 3, Chapter 4 of the Streets and Highways Code of the State of California.

- 5. That a private ingress and egress easement shall be reserved and excepted from the summary vacation of the Portions for the benefit of owners of APN 135-102-010 and APN 135-102-008.
- 6. That an easement shall be reserved and excepted from the summary vacation of the Portions for Fire Department and emergency vehicles and personnel access in the event of any emergency or when County Fire may require access to reach neighboring properties.
- 7. All other rights in the non-exclusive access easement not herein acquired shall be reserved by the owner except that no permanent improvements, fences, vegetation or permanent encroachments of any kind may be erected thereon or other use made which would interfere with the access rights described herein.
- 8. That the Portions are hereby removed from the COUNTY Road Maintenance System.
- 9. That from and after the date the resolution is recorded, the street, highway, or public service easement vacated no longer constitutes a street, highway, or public service easement.
- 10. That the summary vacation of the Portions shall not be final until the COUNTY has recorded the final <u>Order to Vacate</u>.
- 11. That this Resolution, attested to by the Clerk of the Board under the seal of the Board, shall be recorded in the Office of the County Recorder in the County of Santa Barbara, State of California, and that the date of recording shall become the effective date of this <u>Order to Vacate</u>.
