Consider Case No. 09AGP-00000-00018 for approval of one new non-prime agricultural preserve contract for the Walter J. Holmdahl and Genevieve Holmdahl Trust B.

A. Approve and direct execution and recordation by the Clerk of the Board of new contract 09AGP-00000-00018. The new contract involves a portion of Assessor's Parcel Number 083-030-010 located at 2541 San Miguelito Road, approximately 2 miles south of the City of Lompoc, Third Supervisorial District.

Summary Text:

Assessor Parcel Number 083-030-010 is comprised of four legal parcels consisting of 382.44 acres. The owner has obtained Certificates of Compliance for the underlying parcels. The owner is seeking to enroll one 110.57-acre legal parcel in the Agricultural Preserve program. A commercial cattle grazing operation is the principle agricultural use of the property. The remaining 271.87 acres of the Assessor Parcel will not be enrolled. On September 4, 2009, the Agricultural Preserve Advisory Committee reviewed the project and found it to be consistent with the Uniform Rules for Agricultural Preserves and Farmland Security Zones.

Background:

Government Code §51200 (known as the California Land Conservation Act of 1965 or the Williamson Act) provides that local jurisdictions may establish an agricultural preserve program having the goal of retaining land

in an agricultural use. The County of Santa Barbara has adopted such a program which is codified under the Uniform Rules for Agricultural Preserves and Farmland Security Zones. Both the County's Uniform Rules and the Government Code provide that agricultural preserve contracts between the County and landowners are voluntary. Therefore, there are no state mandates associated with this program.

There are no fees associated with replacement contracts. The cost for the contract review and preparation of this report is estimated to be \$2,280.00, and is budgeted in the Agricultural Planning program on Page D-323 of the adopted 2009–2010 fiscal year budget.
