### Summary Text:

This item is on the agenda in order to approve and execute Agreements with WRECO to provide technical investigation, hydrologic analyses and engineering design for the Cold Springs, San Ysidro and Romero Creek Debris Basin Improvement Projects.

WRECO is a bay-area engineering firm with extensive knowledge of Santa Barbara area watershed systems. WRECO designed the Gobernador Debris Basin outlet control structure which withstood the 1-9 Debris Flow Event. WRECO is included on the Board-approved Prequalified Consultant List for Flood Control Engineering. The Board approved the Prequalified Consultant list in January 2018. WRECO was selected to provide geotechnical, hydrologic, and engineering design services for these debris basin projects based on their demonstrated competence and professional qualifications. The design phase for all three projects is expected to be completed by June of 2021.

#### **Background:**

In December 2017 and into January 2018, the Thomas Fire severely impacted the watersheds above Montecito and Carpinteria. District proposes to improve load bearing and conveyance of Cold Springs, San Ysidro and Romero Creek Debris Basins by installing outlet control structures similar to that of the Gobernador Debris Basin built in 2008. The outlet control structures will be designed to withstand the forces of large debris loads, to facilitate sediment delivery downstream, and to restore federally-endangered steelhead trout habitat.

The District was recently awarded a California department of Fish and Wildlife Proposition 1 Grant to help fund design costs. The District has applied for grants from FEMA to help fund construction of the projects, and will be applying for additional grants to help with design and implementation costs. Costs associate with the design are expected to be applied to matching funds for project construction grants.
