Summary Text:

The County routinely requires legal advice and representation in defending against tort and real property claims and litigation. While the Office of County Counsel regularly provides those legal services, under some circumstances it is necessary or beneficial for the County to retain the services of a qualified private law firm to provide those services. County Counsel recommends retaining the firm Manning & Kass, Ellrod, Ramirez, Trester LLP for that purpose, within the two-year term and \$250,000 limit of this proposed contract. The County's excess insurer, CSAC-EIA, has confirmed that the reasonable costs of legal services by Outside Counsel in such matters will count toward satisfying the County's Self-Insured Retention.
