- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for the 2017/18 North County Pavement Rehabilitation Project; County Project No. 820678N in the Third, Fourth and Fifth Supervisorial Districts for work performed and materials supplied by Souza Construction, Inc., (A Tri-County Vendor), 4027 Santa Fe Road, San Luis Obispo, CA 93401, in the amount of \$1,569,192.95; and
- b) Determine that the project was found by the Board to be exempt from the provisions of California Environmental Quality Act pursuant State Guidelines Section 15301(c) on March 13, 2018, a Notice of Exemption was filed on that basis, and the proposed action is within the scope of that Notice of Exemption.

Summary Text:

This agenda item is to approve the project as constructed and the attached Statement of Final Quantities. This project is part of the Pavement Preservation Program.

On March 13, 2018, your Board awarded the above referenced contract to Souza Construction, Inc., and construction began on June 4, 2018. The Director of Public Works accepted this project as completed on December 15, 2018. Construction costs were within the Board Awarded Construction Contract amount.

Background:

Pavement rehabilitation projects are one strategy the Department employs in its Pavement Preservation Program. The first step is to repair small failed areas and concrete. The roadway is then milled to a specified depth and new pavement is placed on top of the remaining structural section. Striping and pavement markings are the final step in construction.

This project resurfaced approximately five lane miles of County maintained roads. Locations were in the Third, Fourth and Fifth Supervisorial Districts.
