Budget Action: Establish appropriations of \$76,000 in the Social Services Department in Social Services WIOA-WDB fund for Salaries and Employee Benefits of \$46,000, and Services and Supplies of \$30,000 funded by unanticipated revenue from Intergovernmental Revenue-Federal by the California Department of Rehabilitation.							

Justification: The County of Santa Barbara Workforce Development Board was awarded a one-time Summer Training and Employment Program for Students (STEPS) grant in the amount of \$76,000 to administer pre-vocational training and work experience services for Students with Disabilities (SWD) in Santa Barbara County. The Foundation for California Community Colleges, in coordination with the California Department of Rehabilitation, is the designated agency responsible for managing the federal funds allocated for STEPS. This budget adjustment increases appropriations for (1) salaries and employee benefits to cover the staff and administrative costs associated with administering the program, and (2) services and supplies to cover the costs of contracting with Goodwill of Ventura and Santa Barbara Counties to serve as the STEPS program operator. There is no impact to the General Fund.
