Re: Emergency Moratorium and Update of County Telecom Ordinances December 1, 2009 Hearing

Dear County Supervisors & Planning and Development Department,

I request that the County Board of Supervisors delay the approvals for the NextG site applications currently under review with the County Planning Department and slated for approvals by November 18, 2009.

Using the FCC telecommunication guidelines from 1996 to allow land use for the latest in cellular antennas without a more complete review, does not serve the interest of the local population. Although improvement in cellular communication is desirable, the approval for the cellular sites on existing telephone poles as a Tier 1 review is inadequate and does not serve the best interest of the community at large.

My concerns include

- A facility is proposed at 171 Old Mill Road near my home.
- I don't know if there are health effects of living near these facilities, but I know that *the quality of life* will be degraded by the uncertainty surrounding these facilities.
- Aesthetics, ambiance and neighborhood compatibility I don't want my neighborhood becoming more industrialized through high tech installations. What is next? The proposed facilities *adversely affect neighborhood aesthetics in terms of the feel of the neighborhood. It is an incompatible land use* in a residential area.
- Fear of potential health risks. Specifically, there is concern for the effects of the radio frequency radiation on the central nervous system and the immune system as well as other metabolic effects observed in preliminary studies.
- Properties and neighborhoods become stigmatized reducing home values.
- RF analysis in the NextG application is suspect.
- Accumulative impact of multiple carriers is not addressed in application.
- Future of putting unsightly poles and wires underground becomes extremely unlikely because of shared usage.

Recommended Actions

- That the Board adopts a 45-day emergency moratorium in order to allow staff and County Counsel to develop a one-year moratorium proposal for your consideration.
 The purpose of both is to allow sufficient time for telecom ordinance updates to handle newly emerging wireless technology applications.
- 2) Direct staff of Planning and Development to initiate General Plan amendments including but not limited to elimination of the "utility pole" loophole. These applications should be removed from the Tier 1 Project classification (very small facilities only) and make any wireless facility mounted on a utility pole subject to the same zone restrictions and CUP processing requirements of the zone in which the utility ROW is located.
- 3) Further amend Santa Barbara County's telecommunications ordinances to strengthen our planning and zoning protections to levels enjoyed by other communities and still allowed under federal preemptions of Section 704 of the 1996 Telecommunications Act.
