On February 17, 2009, the Board of Supervisors authorized the Director of Public Works to advertise for construction bids for the 2009 American Recovery and Reinvestment Act (ARRA), and approved the CEQA Notice of Exemptions and road rehabilitation locations. This project received the Authority for Construction approval from Caltrans on May 5, 2009. The project was awarded by the Board of Supervisors on June 23, 2009, to repair failed pavement areas and placement of a Type-B Asphalt Concrete Overlay over a Stress Absorbing Membrane Interlayer (SAMI), and asphalt concrete leveling course.
