

Dear Santa Barbara County Board of Supervisors:

The League of Women Voters of Santa Barbara supports the adoption of the Strategic Energy Plan and expediting the implementation of Phase 1 and Phase 2 actions recommended in the SEP, while keeping in mind solutions to the financial and funding barriers identified for Phase 3.

We strongly support the goals of reducing greenhouse gases, increasing resiliency, meeting state and local goals on clean energy, and doing this by investing, where possible, in the local economy and jobs. The SEP does an excellent job of defining goals, analyzing potential resources, listing problems, and describing options and costs. We also appreciate the Board directing staff to expedite the solar permit application process and change the County regulations that are limiting the size of solar projects.

The problems involved with what we can do, and how fast we can act, involve major unknowns such as in funding, SCE cooperation, and changes needed in State and local regulations.

Joining the Monterey Bay Community Power CCE goes a long way to securing funding and administrative support to cover the state mandates and local goals in clean energy and greenhouse gas reduction. Joining the Monterey CCE was a viable financial pathway, but it involved losing some local control and local investment especially in the area of resiliency. To address this we support Monterey Bay Community Power, where applicable, moving program and funding decisions to smaller, local government groups to better meet local needs.

While we are encouraged by the resources available and what can be done now, we are also worried by the problems faced. We will not be able develop full resilience for our area unless we can work out equitable solutions to

- The size of solar installations allowed,
- Payments for excess power generated,
- Utility exit fees to customers who join a CCE, and
- The incorporation of local generation and storage into the grid. We support Clean Coalition's Goleta Load Pocket Community Grid Initiative.
