## Second Amendment

This is a *Second* Amendment (*Second* Amendment to the Agreement) to the Agreement for Services of Independent Contractor, by and between the **County of Santa Barbara** (COUNTY) and **eVerge Group, LLC** (CONTRACTOR).

WHEREAS, on August 22, 2017, COUNTY approved the Agreement for Services of Independent Contractor, number BC#18-109, (Agreement) for the implementation consultation and configurations for the implementation of an Oracle Cloud Services Human Capital Management System (HCM);

WHEREAS, the initial term of the Agreement commenced on August 22, 2017, and was expired on June 30, 2019;

WHEREAS, on April 9, 2019, the COUNTY approved the First Amendment to the Agreement to *increase the compensation, extend the expiration date (First Extension Period)* and *modify the scope* of work of the existing Agreement;

WHEREAS, the amended term of the Agreement is set to expire on October 1, 2019; and

WHEREAS, the parties now desire to amend the Agreement to extend the term commencing on August 22, 2017 through February 29, 2020 (Second Extension Period).

**NOW**, **THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

## The Agreement is amended as follows:

1. Section 4, **TERM**, of the Agreement, is amended to state in its entirety:

CONTRACTOR shall commence performance on August 22, 2017, and end performance upon completion, but no later than *February 29, 2020*, unless otherwise directed by COUNTY or unless earlier terminated.

- 2. Item 1 of Step 2 of Exhibit A, is amended to state in its entirety:
  - Following are the tasks to be completed by CONTRACTOR by <u>February 29, 2020</u> after completion and acceptance of Step 1:

In all other respects, the Agreement remains unchanged and shall remain in full effect.
