Summary Text:


This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities. On April 9, 2019, your Board awarded the above referenced contract to Raminha Construction, Inc., and construction began on May 13, 2019. The Director of Public Works accepted this project as completed on August 2, 2019. Construction costs were within the Board awarded construction contract amount.

Background:

The project is located on Ortega Ridge Road, approximately 850 feet north of Greenwell Avenue, near Summerland. The County developed and funded the project in coordination with CalRecycle and GHD Services Incorporated (GHD) to construct a long-term solution to the differential settlement and cracking of the roadway surface and creep failure of the supporting embankment at the project site. The project constructed a Mechanically Stabilized Earth (MSE) wall utilizing Tire-Derived Aggregated (TDA) as a lightweight fill material. This project will reduce the load imposed on the underlying earthen materials and provide lateral resistance to the roadway fill.
