- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for the East Mountain Drive Rockfall Attenuator System Project; County Project No. 18104C; Federal Aid Project No. 4535DR-CA-42121; First Supervisorial District for work performed and materials supplied by Sunquest General Engineering (not a local vendor), 16128 Fruitvale Road Valley Center, CA 92082, in the amount of \$190,927.50; and
- b) Determine that the project was found by the Board to be exempt from the provisions of California Environmental Quality Act pursuant to 14 CCR 15269 (d) on November 06, 2018, a Notice of Exemption was filed on that basis, and the proposed action is within the scope of that Notice of Exemption.

Summary Text:

This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities. This project is storm damage repair.

On April 9, 2019 the Board awarded the above referenced construction contract to Sunquest General Engineering, and construction work began on May 17, 2019. The Director of Public Works accepted this project as completed on July 22, 2019. Construction costs were within the Board awarded construction contract amount.

Background:

This project is located on East Mountain Drive in Montecito, less than one mile northwest of Ashley Road. The project constructed a rockfall attenuator system as well as a flexible rockfall barrier along the east side of the roadway. This project mitigated the rockfall hazard and facilitated the reconstruction of this segment of East Mountain Drive.

The total construction cost, including contingencies amount to \$190,927.50.

Federal Aid for Disaster funds (FEMA Category C) funded \$143,195.63 (75%) of construction costs; State Aid for Disaster funds (CAL OES) funded \$35,798.90 (18.75%); and the First Supervisorial District's share of General Fund funded \$11,932.97 (6.25%).

Funds for this project were budgeted in Dept. 054, Fund 0016, Org Unit 0500, Line Item Account 7510.
