Increase Appropriations to Recognize the Youth Reinvestment Grant (YRG) Expenditures and Revenues

Budget Action: Increase appropriations of \$276,150 in Probation Department General Fund for Services and Supplies funded by unanticipated State revenue for FY 19-20 Youth Reinvestment Grant (\$220,920) and release of Restricted Probation LESF/COPS fund balance (JJCPA Reserves \$55,230).

Justification: The Santa Barbara County Probation Department was awarded \$795,193 in YRG funds for a grant period commencing 7/1/19 and ending 2/28/23. YRG will provide funds for the diversion of low-level and low risk youthful offenders at the point of their initial contact with law enforcement in order to reduce the number of youth who enter the juvenile justice system. It is anticipated that the initial allocation of YRG funds (\$276,150) will be distributed in October 2019.
