That the Board of Supervisors consider the following:

- a) Approve, ratify, and authorize the Chair to execute two, separate agreements to provide Law Enforcement Services between the County of Santa Barbara and the Cities of Buellton (Traffic Deputy) and Solvang (Community Resource Deputy), for a term of one (1) year and;
- b) Determine that the recommended action is not a "Project" within the meaning of California Environmental Quality Act, pursuant to CEQA Guideline Section 15378(b)(4), since the recommended action is a government fiscal activity which does not involve commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

This item is on the agenda to execute two, separate Agreements to Provide Law Enforcement Services between the County of Santa Barbara and the Cities of Buellton (Traffic Deputy) and Solvang (Community Resource Deputy). These services are in addition to the already signed DSSU contract and will act as menu items for fiscal year 2019-20. The term is for a period of one year.

Background:

The Sheriff's Office and the contract cities of Buellton and Solvang will enter into an agreement to provide additional services separate from the already agreed upon and signed 2019-20 Deputy Sheriff's Service Unit contract. The City of Buellton has requested Traffic Deputy services (2080 hours) and the City of Solvang has requested Community Resource Deputy services (2080 hours) for fiscal year 2019-20. These services will be provided by the Sheriff's Office per a one (1) year agreement for fiscal year 2019-20. The Sheriff's Office cost recovery will consist of the Deputies salary and benefits, the indirect cost rate (7.49%) and the hourly Contract Service bureau charge of \$1.80 per hour purchased. This does not include costs of supervision, support, and supplies for the position, which were calculated by the Auditor-Controller's Office to be \$79,910 for each City's position.
