- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for Construction of the 2018 Isla Vista Sidewalk Infill Trigo Road Project; County Project No. 820692; Third Supervisorial District, for work performed and materials supplied by J.J. Fisher Construction, Inc. (a Tri-County Vendor), 261 W Dana Street, Suite 102, Nipomo CA, 93444, in the amount of \$603,634.64, and
- b) Determine that this project was found by the Board to be exempt from the provisions of the California Environmental Quality Act pursuant to State Guidelines Section 15301, on July 25, 2017 upon approval of the project, that a Notice of Exemption was filed on that basis, and that the proposed action is within the scope of that Notice of Exemption.

Summary Text:

This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities. This Project, funded by the SB 1 Gas Tax, with a 50% match by UCSB has been constructed for improving pedestrian flow in Isla Vista.

On December 4, 2018, the Board awarded the above referenced construction contract to J.J. Fisher Construction, and construction work began on December 19, 2018. The Director of Public Works accepted this project as complete on August 30, 2019. Construction costs were within the Board awarded construction contract amount.

Background:

This project constructed a sidewalk to provide a continuous pedestrian path on the north side of Trigo Road from Camino Corto to Camino Pescadero, for a total length of 2,280 feet. The construction of sidewalks at these locations completed key links in the sidewalk network and improved the pedestrian route in the Isla Vista area.

Total construction costs, including supplemental work and contingencies came to \$603,634.64. The SB 1 Gas Tax funded 50% of the construction costs, with a matching contribution from UCSB. Funds for this project were budgeted in Dept. 054, Fund 0016, Org Unit 0500, Program 2720, and Account 7510.
