# THIRD AMENDMENT Effective January 1, 2018

This Third Amendment (hereafter referred to as Third Amendment) is to the Agreement for Services, number BC-05-168 (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and American Medical Response West (CONTRACTOR), for the provision of emergency and non-emergency ambulance service for advance life support and pre-hospital care.

**WHEREAS**, on August 20, 2013 a second amendment exercising an option to extend the term of the Agreement was executed;

WHEREAS, the current term of the Agreement is effective through December 31, 2017;

WHEREAS, the parties desire to amend the Agreement to extend the term:

**WHEREAS**, this Third Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this Third Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

### 2. Amendments.

- a. The Agreement is amended as follows:
  - SECTION 1 ADMINISTRATION OF THE CONTRACT AND TERMS

### 1.2 Term of Contract

The term of this Agreement shall commence at 00:01 hours on January 1, 2005 (Effective Date), and shall terminate at midnight on December 31, 2019, unless terminated earlier pursuant to the terms and conditions of this Agreement.

- 3. <u>Incorporation.</u> The terms and provisions set forth in this Third Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this Third Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
- 4. <u>Counterparts.</u> This Third Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
