Justification: In FY 2018-19, the Board approved the acquisition of a used Sikorsky HH 6+0L (Blackhawk) helicopter. The aircraft requires modifications to be mission ready

for the Santa Barbara County Air Support Unit. The scope of work includes de-modification of military specific equipment, major airframe maintenance,

mission specific airframe modifications, replacing avionic equipment and painting the aircraft. Per Auditor-Controller direction, the Black Hawk helicopter build-up is more appropriately classified as a capital asset equipment expense. This budget revision transfers the appropriations from equipment maintenance to

capital assets equipment.
