- b) Approve and authorize the Chair to execute the attached Statements of Final Quantities for the 2018/2019 Pavement Rehabilitation Project No. 820679 D3 in the Third Supervisorial District, for pavement presentation work by Souza Construction, Inc. in the amount of \$1,269,535.51;
- c) Approve and authorize the Chair to execute the attached Statements of Final Quantities for the 2018/2019 Pavement Rehabilitation Project No. 820679 D4 in the Fourth Supervisorial District, for pavement presentation work by Souza Construction, Inc. in the amount of \$943,174.84;
- d) Approve and authorize the Chair to execute the attached Statements of Final Quantities for the 2018/2019 Pavement Rehabilitation Project No. 820679 D5 in the Fifth Supervisorial District, for pavement presentation work by Ferravanti Construction in the amount of \$349,113.13; and
- e) Determine that the above projects found by the Board to be exempt from the provisions of California Environmental Quality Act pursuant State Guidelines Section 15301(c) on May 15, 2018, a Notice of Exemption was filed on that basis, and the proposed exemption is within the scope of that Notice of Exemption. Summary Text:

This item is on the agenda to approve the projects as constructed and the attached Statements of Final Quantities for the four construction contracts. These projects are part of the Pavement Preservation Program.

On April 9, 2019, your Board awarded the above referenced contracts to the following:

<u>District 2</u> – Granite Construction, Inc. Construction began on April 29, 2019. The Director of Public Works accepted this project as completed on June 27, 2019.

<u>District 3</u> – Souza Construction, Inc. Construction began on April 30, 2019. The Director of Public Works accepted this project as completed on July 3, 2019.

<u>District 4</u> - Souza Construction, Inc. Construction began on May 22, 2019. The Director of Public Works accepted this project as completed on July 9, 2019.

<u>District 5</u> – Ferravanti Grading and Paving. Construction began on April 29, 2019. The Director of Public Works accepted this project as completed on May 31, 2019.

Construction costs were within the Board awarded construction contract amounts.

Background:

Pavement rehabilitation projects are one strategy the Department employs in its Pavement Preservation Program. The first step is to repair small failed areas and concrete. The roadway is then milled to a specified depth and new pavement is placed on top of the remaining structural section. Striping and pavement markings are the final step in construction.

These projects resurfaced approximately nineteen lane miles on County maintained roads. Locations were in the Second, Third, Fourth, and Fifth Supervisorial Districts.
