Dental: Two (2) Grievances (7.69%)

There were two (2) grievances related to dental treatment for April. Both were for dental treatment for an abscess. One (1) was put on antibiotics and then was treated by the dentist a week later. The second was placed on pain medication and antibiotics after refusing to be anesthetized by the dentist. No appeals were filed and neither grievance required follow-up to determine a resolution.

Mental Health: Two (2) Grievances (7/69%)

During this period, there were two (2) mental health grievances for review. Both grievances requested treatment by Mental Health. In both cases, treatment was provided, but one lacked detail because the HIPAA release was not signed. No appeals were filed and neither grievance required follow-up to determine a resolution.

Medications: Seven (7) Grievance (26.92%)

I reviewed seven (7) grievances related to medications other than mental health medications. Treatment and medication adjustments resolved each of these requests. Two (2) were complaints about crushed and floated medication, with one of these being a duplicate of the first complaint. Two (2) were because medication was not being provided, one (1) was a request for a dosage adjustment or continuation of antibiotics, one (1) was a request for allergy medication and one (1) was for a benzo drug that cannot be prescribed. No appeals were filed and no grievances required follow-up to determine an appropriate outcome.

Medical: Fifteen (15) Grievances (57.69%)

I reviewed fifteen (15) general medical grievances for this period. Sick call, MD and follow-up appointments or other similar actions addressed the majority of these complaints. One (1) was for a kosher diet that is really not a medical issue and another was because a medically approved diet was discontinued by the kitchen in error. No appeals were filed and none of the grievances required follow-up to determine a resolution.

Observations & Recommendations:

The average time between the grievance filing and a response from medical or mental health during this period is 4.7 days. No grievances exceeded the fifteen (15) day response requirement.

During this period, the total number of medical related grievances decreased slightly, with one (1) being a duplicate grievance. When comparing the twenty-six (26) grievances filed for this month to the average of thirty (30) grievances per month filed in the previous quarter, this is a decrease of 13.33%.

In the month of April, there were 1,438¹ requests for medical related services, of which twenty-six (26) or 1.8% resulted in a grievance. This is a 40% decrease comparative to the average of 3% filed during the previous quarter.

During this same period, there were one hundred twenty-three (123) total grievances filed, of which twenty-six (26), or 21.1% were medical related.

In the month of April, the sheriff's office received zero (0) community inquiries.
