## Approving a Lease

FOR SEASONAL INSTALLATION AND MAINTENANCE OF SWIM AND CHANNEL MARKER BUOYS IN THE PACIFIC OCEAN AT ARROYO BURRO BEACH, GOLETA BEACH, LOOKOUT BEACH, MIRAMAR BEACH AND BUTTERFLY BEACH NEAR GOLETA, MONTECITO AND SUMMERLAND IN SANTA BARBARA COUNTY

WHEREAS, on May 7, 1984 certain beach areas were declared "Special Use Areas" by the Santa Barbara County Board of Supervisors for the purpose of protecting persons recreating in designated limited areas of the Pacific Ocean from motor-powered boats or other powered water devices along the Santa Barbara County shoreline; and

WHEREAS, these "Special Use Areas" are known as Goleta Beach, Arroyo Burro Beach, Lookout Beach, Butterfly Beach and Miramar Beach; and

WHEREAS, the County of Santa Barbara desires to continue the use of these areas as "Special Use Areas" and desires to continue the placement of necessary buoys or floats and signs to designate these "Special Use Areas"; and

WHEREAS, the placement of these buoys or floats and signs requires a Lease from the State Lands Commission.

**NOW, THEREFORE, BE IT RESOLVED** that the County of Santa Barbara Board of Supervisors hereby

- 1. Approves the Lease for seasonal installation and maintenance of swim and channel marker buoys in the Pacific Ocean at Arroyo Burro Beach, Goleta Beach, Lookout Beach, Miramar Beach and Butterfly Beach near Goleta, Montecito, Summerland in Santa Barbara County; and
- 2. Delegates the authority to the Director of Community Services to sign and submit all documents, including, but not limited to applications and payment requests, which may be necessary.
