Attached is evidence (timeline + documents) demonstrating Busy Bee Organic's (Busy Bee) Legal Non-conforming Use (medical marijuana cultivation) prior to January 19, 2016 that was submitted to the County (Ms. Analise Merlo) and the County Cannabis Enforcement team. This information was submitted to the County on May 22, 2019 during the onsite inspection of Busy Bee's farm in response to a complaint by the attorney for the Santa Barbara Coalition for Responsible Cannabis (Coalition).

This is not new information we are submitting into the record as it was provided to the County nearly one year ago. Instead, we are re-submitting this information in light of allegations made by the Coalition in Mr. Marc Chytilo's March 13, 2019 Letter. We simply want to ensure that the Board of Supervisors has an opportunity to review this information prior to the March 17, 2019 Busy Bee appeal hearing.

Busy Bee Timeline

- 1975-2014: The Farm (1180 W. Hwy 246) was cultivated with conventional row crops (broccoli, spinach, and tomatillos).
- May 22, 2014: Ms. Rotman purchased the Farm (see Attached Grant Deed (#2014-0025522).)
- August 2014: Ms. Rotman health failed due to complications from severe Crohn's disease for which she was subsequently hospitalized.
- As a result of her illness Ms. Rotman resolved to grow cannabis on her farm via all organic practices as she previously had received contaminated CBD oil from California medical collectives. After purchasing the property, she learned that the soil was highly contaminated with pesticides and fertilizers from decades of conventional farming practices.
- October 2014: Ms. Rotman commenced preparing the entire Farm for cannabis cultivation. She hired her next-door neighbor, Mr. Roy Amboy to do the initial field preparation; he conducted the work using his equipment (tractor). This included grading and discing all arable acreage of the farm and prepping the entire Farm, etc. (See two checks to Ray Amboy, neighbor on 1/21/2015.) Ms. Rotman then planted a rye cover crop to regenerate the soil. Rye's deep roots help prevent compaction in annually tilled fields, and because its roots are quite extensive, rye also has a positive effect on soil tilth. That initial crop failed due to high levels of soil contamination.
- **February 2015:** Ms. Rotman began studying the work of Joel Salatin (http://www.polyfacefarms.com/our-story/) and began purchasing chickens to work the soil. Ultimately, she had 1100 chickens and goats grazing the soil in order to naturally restore the soil in preparation for planting the full farm with cannabis. (See receipts and photographs.)
- June to July 2015: Ms. Rotman formed Busy Bee's Organics, a Medical Collective under the Compassionate Use Act and the Medical Marijuana Program Act. (See Formation Documents and documents filed with the Secretary of State.) At this time, Busy Bee's Organics received its Seller's Permit. (See Seller's Permit.)
- July 2015: Busy Bee's continued prepping entire farm for cultivation—to return soil to organic state takes at least 3 years. (7 CFR 205.202 of the

USDA organic regulations specifies that land used to grow organic crops must have been managed in accordance with 7 CFR 205.203 – 206 of the regulations, and have had no prohibited substances applied to it for three years.) Busy Bee's started planting cannabis seeds in on onsite greenhouse and around the entire farm. (See receipts.)

- **Dec 2017**: Applied for State Temporary Licenses as soon as CDFA opened up state registration process for cannabis cultivators.
- **Feb. 2018**: Obtained State Temporary Licenses.
- June 2018: Applied for Provisional State Licenses.
- July 2018: Busy Bee's started erecting hoop houses.
- October 2018: Hired Chris Price (Price Postal) (land use planner) to prepare County cannabis Land Use application.
- **November 2018:** Hired SEPPs (Land Use Planner) to complete County application.
- **November 2018:** Applied for County LUP.
- April 2019: Received State Provisional License Approval.
- April 2019-July 2019: Obtained State Provisional Licenses.
- May 7, 2019: County approved the Busy Bee LUP for 22 acres of cannabis cultivation after numerous site visits.



To Whom It May Concern:

Our office is legal counsel to the BUSY BEE'S ORGANICS ("Collective"), a state registered Unincorporated Nonprofit Association.

The purpose of this letter is (1) to inform you that BUSY BEE'S ORGANICS is a valid collective of qualified medical marijuana patients under the laws of the State of California governing medical marijuana (the Compassionate Use Act and the Medical Marijuana Program Act) and that the holder of this letter is the Collective's designee for purposes of cultivating the Collective's medicine and/or transporting it from the Collective's garden and member cultivators to its members throughout California; primarily in Los Angeles and Santa Barbara Counties; and (2) to explain the legality of the Collective under California law.

In 2003, the California Legislature enacted Senate Bill 420, also known as the Medical Marijuana Program Act ("MMPA"), codified as Health & Safety Code § 11362.7 et seq., which provides that qualified medical marijuana patients and primary caregivers may "associate within the State of California in Order collectively or cooperatively to cultivate marijuana for medical purposes." (See Health and Safety Code § 11362.775.) Collectives and their members engaged in such "collective cultivation" activity, are protected from criminal prosecution for, among other things, marijuana possession (Ca. H&S Code 11357), cultivation (Ca. H&S Code 11358), possession for sale (Ca. H&S Code 11359), and transportation or sale (Ca. H&S Code 11360). See Health & Safety Code 11362.775. The 2008 Attorney General's Guidelines for the Security and Non Diversion of Medical Marijuana Grown for Medical Use, promulgated pursuant to the MMPA (copy attached), set forth guidelines and best practices "to help cooperatives and collectives operate within the law, and to help law enforcement determine whether they are doing so." (See Attorney General Guidelines Section IV.A and IV.B)

Notably, the 2008 Attorney General's Guidelines authorize members of a medical marijuana collective to cultivate and transport marijuana on behalf of the Collective and its members. Likewise, the Courts in California have construed the MMPA as allowing such activity within the collective cultivation defense. See, e.g., People v. Anderson, 223 Cal. App.4th 1259, 1262 (2015); People v. Colvin, 203 Cal. App.4th 1029 (2013); People v. Jackson, 210 Cal. App.4th 525 (2012); People v. Urziceanu, 132 Cal. App.4th 525 (2005).

As per Section IV.A and IV.B.1, the Collective is member owned, registered with the State of California as an unincorporated nonprofit association (Entity Number 14720), and operated consistent with nonprofit economic and accounting principles.

As per Section IV.B.2, the Collective has obtained an EIN number from the Internal Revenue Service, and a seller's permit from the State Board of Equalization. In this way, the Collective is paying federal and state taxes. There is no requirement for the Collective to obtain a business license either from Los Angeles or Santa Barbara County.

As per Section IV.B.3, before becoming a member of the Collective, each prospective member must fill out a lengthy membership agreement, provide proof of California residency. and a recommendation for the use of medical marijuana. Members must have a written recommendation for medical marijuana from a licensed physician who is currently licensed to practice medicine in the state, and/or a state-issued identification card issued by the Department of Health Services verifying their status as a qualified medical marijuana patient. The Collective verifies the validity of the recommendation and that the doctor issuing the recommendation is in good-standing with the governing medical board, unless the member has a state-issued card in which case it is only necessary to verify the validity of the card. The membership agreement requires that the prospective Collective member agree to a series of rules and conditions of membership, including that, they agree not to distribute marijuana or derivative products to non-members and agree not to use marijuana products other than for medical purposes. The Collective maintains membership records in a way that is reasonably available, tracks the expiration dates for membership recommendations and DHS cards, and enforces its rules including excluding or terminating members that have invalid recommendations or divert medical marijuana obtained through the Collective.

As per Section IV.B.4, the Collective Acquires, Possesses, and Distributes Only Lawfully Cultivated Cannabis. Members of the Collective maintain gardens on behalf of the Collective and are the exclusive sources of marijuana grown and derivative products produced for the members of the Collective. Thus, the Collective receives medicine from the members who grow it, and provides medicine to members in need, and operates as a closed circuit, isolated from the illicit market in cannabis. Accordingly, the Collective does not receive any medicine from any source other than its members (§§ 11362.765, 11362.775).

As per Section V.B.5, the Collective does not allow the distribution or transporting or receipt of marijuana or derivative products to or from non-members in good standing. Thus, the Collective's policy is that it does not authorize medical cannabis brokers or intermediaries to buy commercial quantities of cannabis on the illicit market and then provide it to the Collective. Any inter-state activity, acquisition of or distribution of medicine is strictly prohibited. All medicine acquired and provided at the Collective is to be grown by registered members who are legally entitled to do so inside the state of California. No medicine can come from outside

California, and it is never legal to distribute medicine outside of the state. Collective Member has in his/her possession a document executed by both he/she and by an authorized agent of the Collective attesting to these facts and the other representations set forth herein.

As per Sections V.B.5 and V.B.6, members of the Collective reimburse it for marijuana and derivative products provided to the respective member by the Collective, and in turn the Collective compensates the growing member for its respective contributions, in amounts designed to cover their overhead costs and operating expenses. Other members of the Collective receive medicine free of charge or at reduced cost in exchange for services provided to the collective.

As per Section V.B.7, the possessing Collective Member and the collective generally "may cultivate and transport marijuana in aggregate amounts tied to its membership numbers;" and is authorized to operate a location for cultivation, transport the group's medical marijuana; and operate a location for distribution to members of the collective.

As per Section V.B.8, the Collective has in place measures designed to ensure that its members are granted safe access to medicine, and that the members and surrounding homes and business are in no way negatively impacted by its activity.

The Attorney General Guidelines set forth certain indicia of deviations from the Guidelines and/or that marijuana is not for medical use which "may give rise to probable cause for arrest and seizure." Those indicia include (a) excessive amounts of marijuana relative to its membership and needs; excessive (b) amounts of cash; (c) failure to pay taxes; (d) weapons; (e) illicit drugs; (f) purchases from, or sales or distribution to, non-members; or (g) distribution outside California. The absence of such indicia should logically weigh against arrest or seizure and, pursuant to People v. Mower (2002), 28 Cal.4th 457, in evaluating whether there is probable cause that a crime is being committed law enforcement must evaluate the surrounding facts including person's status as a qualified patient. See also People v. Russell, (2006) 41 Cal.Rptr.3d 668 (Third District COA, March 16, 2006) (holding that observance of marijuana cultivation outside residence did not provide probable cause for search where defendant posted notice outside grow that he was medical marijuana patient). In other words, because there is a lack of indicia of deviation from the Attorney General's Guidelines, or the MMPA, I urge you to not seize Collective Member or any of the medicine in his possession on behalf of the Collective.

As the Collective's attorney, I have advised all Collective members not to speak with Law Enforcement until I have the ability to be present, if they so decide. If you are reading this letter in regard to a criminal investigation, I request that you review the attached documents including, State of California Entity, and accompanying documents pertaining to the Collective, before citing or arresting Collective Member. I understand that the laws pertaining to medical

marijuana and, in particular, collectives are somewhat confusing, and that you personally may disagree with those laws. Nonetheless, I assure you that the legal statements set forth herein are accurate and these documents in the possession of Collective Member are designed to demonstrate the Collective's and the Collective Member's compliance with those legal authorities.

ARTICLES OF ASSOCIATION

To further common purposes, the members agree to organize under these articles of association.

Article 1: Name

The name of this association shall be BUSY BEE'S ORGANICS COLLECTIVE (herein after "BUSY BEE'S ORGANICS COLLECTIVE," the "Collective" or the "Association")

Article 2: Address

The principal address of the Association shall be located at: 270 EAST HIGHWAY 246, STE. 109, BOX #104, BUELLTON, CA 93427. The Association may establish other addresses and offices as may from time to time be designated by its members or its executive committee.

Article 3: Purposes

The purposes for which this Association is formed are:

- A. To associate within the State of California in order to collectively and cooperatively cultivate marijuana for medical purposes.
- B. To be organized and operated in a manner that ensures the security of the crop and safeguards against diversion for non-medical purposes.
- C. To provide a means for facilitating or coordinating transactions regarding medical marijuana between members of the Collective.
 - D. To ensure against purchase of medical marijuana from, or sales to, non-members.
- E. To do anything necessary and proper for the accomplishment of any purposes set forth in Constitution and Bylaws adopted by the founders of this Association.

This Association is organized and operated exclusively for the above-stated purposes, and for other not-for-profit purposes. No part of any net earnings shall inure to the benefit of any private member.

Article 4: Powers

In furtherance of the objectives described above, but not in limitation of such objectives, the Association shall have the power, insofar as such power is conferred, or is not limited by California State law, to make and perform contracts for any State of California lawful purpose, to engage in various funding and fund-raising activities and to acquire, own, hold, operate and maintain such property as to effectuate its purposes.

Article 5: Membership

The Association shall have one class of members only. All voting rights and other rights, interests and privileges of each member shall be equal. The rights and privileges of members, their liability for dues and assessments and the termination and transfer of membership shall be as stated in the Association's Bylaws.

Article 6: Governing Body

The powers of the Association shall be exercised and its property controlled by a Governing Body. The number, qualifications, the time and manner of election, the terms and duties of office and the manner of filling vacancies shall be set forth in the Association's Bylaws. The founding member(s) and initiating Governing Body member(s) shall be SARA ROTMAN and NATHAN DIAZ.

Article 7: Officers

The officers of this Association shall be a President, vice president, secretary, and treasurer. Other offices and officers may be established or appointed by members of the Association at the regular annual meeting. The qualifications of, the time and manner of electing, the duties of, the terms of office of, and the manner of removing officers shall be set forth in the Association's Bylaws.

Article 8: Bylaws

Bylaws will be hereafter adopted. Such Bylaws may be amended or repealed, in whole or in part, in the manner they provide, and the amendments to the Bylaws shall be binding on all members, including those who may have voted against them.

Article 9: Dissolution

This Association shall be dissolved and its affairs wound up upon a resolution of the Governing Body and a vote in favor of dissolution by at least 65% of the Association' members. Upon such resolution and vote, the Association shall be dissolved in accordance with California law.

Article 10: Distribution of Property on Dissolution

In the event of dissolution, property of the Association shall be distributed as follows: the property shall, at the sole discretion of the council, either be returned to the member who contributed the property or sold with the sale proceeds being distributed to the members equally.


