Summary Text:

This item is on the agenda in order to authorize the Public Works Director to advertise and receive bids for the A-Street Basin Weir Structure Reconstruction Project.

This project will reconstruct the weir structure of the A-Street Basin that is located in the City of Santa Maria. The concrete channel weir and inlet structure has reached the end of its useful service life. There have been many repair projects, both routine and emergency, after storm damages in the past. The concrete has significantly deteriorated and the most cost effective option is to reconstruct.
