- 3. The Clerk of the Board is directed to file with the County Auditor-Controller, on or before August 10, 2020, a certified copy of this Resolution and the report, indicating adoption by the Board in accordance with Health and Safety Code Section 5473.4. Upon such filing, the County Auditor-Controller shall enter the charges on the tax roll for the 2020-2021 fiscal year. The charges shall be collected at the same time and in the same manner, and subject to the same penalties and priority of

lien as, County taxes are collected, and all laws providing for the collection and enforcement of County taxes shall apply to the collection and enforcement of the charges.
