NOW, THEREFORE, BE IT RESOLVED, that the <u>County Public Works</u> <u>Director</u> is authorized to execute and file an appropriate claim and necessary claim amendments pursuant to applicable rules and regulations promulgated hereunder, together with all necessary supporting documents, with the Santa Barbara County Association of Governments for an allocation of TDA funds in FY <u>2020/2021</u>;

BE IT FURTHER RESOLVED THAT the authorized claim include \$84,557 for SBCAG's regional transportation planning, \$252,022 for County transit and related work and \$123,939 for pedestrian and bicycle facilities, and \$2,410,000 for Santa Maria, Lompoc, Solvang, Guadalupe, SBCAG, and Santa Maria Organization of Transportation Helpers; and

BE IT FURTHER RESOLVED THAT a copy of this resolution be transmitted to the Santa Barbara County Association of Governments in conjunction with the filing of the claim.
