Chair Hart and Members of the Board of Supervisors,

Please affirm the Planning Commission's denial of the revised Santa Barbara West Coast Farms Project.

Your Planning Commission denied it after careful study.

Commissioner Park stated in the Santa Rita Ag hearing: PEIR did not cover clustering around the gateway to the Santa Ynez Valley, -directly relevant.

This application, with others locally will create an Industrial Cannabis Corridor inconsistent with CEQA ("It is necessary to provide a high-quality environment that at all times is healthful and pleasing to the sense and intellect of man" PRCode 21000) and will not be in alignment with the Santa Ynez Community Plan.

This project's odors will negatively effect residents, visitors and nearby farm workers. This valley's not suited to cannabis operations-Its thermal inversions hold odors and fine particles at ground level.

Agricultural products, ie wine, and wine tasting visitors' experience will be negatively impacted, threatening the livelihood of established vintners and tourist industry.

This project will impact established non-cannabis farms. Fear of cannabis growers' lawsuits stopped professional applicators from applying materials controlling pests and mildew and standard practices (plowing) that stirs up dust. As an avocado farmer, I am concerned non-cannabis farming will be put out of business.

Honorable Board of Supervisors: Please uphold the Planning Commissioners denial of West Coast Farms project

Earth day...April 22, is celebrating its 50<sup>th</sup> anniversary. As many of you know Earth Day was created in Santa Barbara in 1970 a year after the 69' oil spill in the Santa Barbara channel. Decades before the Exxon Valdez or the BP Deepwater Horizon; smaller yet grand for what it eventually led to. Earth Day will be celebrated "virtually". Who could of imagined the tumultuous times we would be experiencing 50 years ago. At first glance Earth day seems un-connected; but what we are experiencing at this moment - a global coronavirus epidemic is in a roundabout way related. The spills, wildfire disasters, droughts and over burden on the earth has caused migration from South American countries not unlike the migrants that left their land in Somalia for a better life in European countries. The mass migrations caused by rising sea levels, drought stricken earth, poor food cultivation conditions and warlord dominance is causing those in need of food and a better life. These events are causing upheavals in the the natural growth of populations and the demand on resources that are already exhausted. Pandemics like the coronavirus will not be once every hundred years; sadly they will be a part of life. Drastically altering land has environmental consequences which gives way to political turmoil. Time will tell how covid 19 was unleashed on the world; but the problematic changes to our world won't curb future pandemics. Mass migrations of cultures seeking food, work and safety and less food bearing land will be disastrous. Our agriculture preserved land in California and on the central coast is vital because of the tepid climate and ability to grow crops all year. Decisions made now to industrialize open spaces can't be made is haste.

The delicate equilibrium of our environment is already evident in longer more frequent heatwaves and droughts. According to the journal of "Science" the mega-drought in our area in 2000 led to the longest driest span since the 1500s. The 18 year drought was preceded by the wettest period 1980's having the most precipitation in 1200 years. This year if it wasn't for a surprising March we would be in bad shape. The sustainability of water is the only way we will be able to feed a nation bulging at its seams with population. We may need to feed parts of the world but we must have the resources. Building up the land with huge industrial buildings and dotting every inch with greenhouses and hoops to grow an extremely thirsty cannabis plant (average 5-6 gallons a day per plant 1 gallon a day when young)) is disheartening and not typical of Santa Barbara County. It's easy to grab at the crop that brings in the most money; but when it alters the land so drastically and threatens the ecosystem and microclimate and demanding huge structures at the location for drying. It changes from agriculture to processing. Grow a strawberry, pick it, ship it. Cannabis is different on many levels. We don't haft to make a strawberry pie before it can leave the property.

All of history is a indicator of the future; the scale and circumstances may differ but the main result is always the same. Changes in drastic manners tend to never go back to the way it was. Too much damage tends to occur and buildings get built with huge footprints and never come down. The earth day movement was born in a time we thought we would never see the changes but we would protect generations in 2050 Not only was that false; but we see the changes now; we have seen the changes for a while. We can see the changes from year to year now. The movement that came out of the oil spill was the greatest precursor to environmental consciousness the world has ever seen. 50 years later we don't have the luxury of making big mistakes and hoping they will not effect us. "The green rush" the cannabis rush for green money often gets thrown into green environmental conversations; but it's in no way environmental. Industrial cannabis as we see proposed in the West Coast project is similar to the Herbal Angels project with a large footprint and the clusterings. The mountain ranges will hold odor and trophesperic smog in the thermal inversions of the landscape. This trapped odor will effect the vineyards in close proximity and incompatible crops. It's possible for Cannabis to be grown responsibly in the county. Cannabis cultivation should occur only in areas where neighboring agriculture and residents aren't jeopardized. Best practices are not being employed by the vast majority of conforming — nonconforming cannabis operations and the neighboring residents, farms and businesses are suffering. The fostering of large scale industrial cannabis is killing everything the County of Santa Barbara is about. Remember we made Earth Day!

Chair Hart and Honorable Supervisiors, Please give serious consideration to your planning commissions finding for denial of this project. This is one of many large scale applications that will create an "industrial" scale cannabis corridor to the west of Buellton that will threaten the quality of life and businesses of this part of Santa Ynez Valley and Santa Rita in particular. #### Honorable Supervisors;

I grew up in Sonoma County. Individual voters in that County have had no more control over their board of supervisors' decisions regarding the treatment of cannabis cultivation since legalization of recreational cannabis than I have over the decisions of our board of supervisors.

Yet it has turned out so much better for them. According to the outstanding brief (letter) drafted and submitted by attorneys Marc Chytilo, Ana Citrin and Courtney Taylor, Sonoma County has a rule that only one acre of cannabis cultivation be permitted per parcel. As a result there are 88 acres of cannabis cultivation in the entire county. With the extraordinary amount of acreage per parcel allowed in Santa Barbara County, the parcels for which permits are currently being sought in the Highway 246 and Santa Rosa Road area not only far outstrip the total allotted for all of Sonoma County but approach or exceed the total anticipated market for the State.

This is not the kind of density appropriate for our county. It threatens to change the character of the wonderful wine country corridor that Highway 246 and Santa Rosa Road have become. It threatens the survivability of traditional agriculture such as avocados due to pesticide issues. It threatens to change the very nature of neighborhood communities such as the Tepusquet EDRN and the Cebada Canyon EDRN. It threatens to take over Carpinteria, driving down home values and driving people out of the area due to odor issues.

Do I wish I still lived in Sonoma County? No. This is my home, and until the cannabis issue raised its ugly head, I have felt very fortunate to live here. But unlike my friends in Sonoma County, my wife and I have had to expend a lot of energy, time and effort in opposing the incredible incursion of cannabis cultivation into this county over the past three years. Do I wish that our board of supervisors had made the same decision regarding acreage per parcel as Sonoma County did? Yes.

Please support the Planning Commission denial of the LUP to "Santa Barbara Westcoast Farms, LLC" (the official LLC name, including no space between West and coast). This Board has the power to put the brakes on the takeover by industrial cannabis cultivation. This is an opportunity to do so.

Our Family has been farming and making wine in the Santa Ynez Valley for almost 50 years. We have three generations in the industry working along with many fine families also with multiple generations. Living and working together is what has created Wine country in Santa Barbara. It has taken many years much effort and much cost to craft the reputation that we now enjoy. Wine growing and wine making have created an industry that is the biggest multiplier industry in Santa Barbara. Many hotels and restaurants as well as other tourism industries rely on and benefit from our areas wineries and vineyards. Our customers come from all over to experience a place of beauty, enjoy the out doors and taste the unique wines produced here.

Wine tasting and the smell of cannabis are simply incompatible

Our Winery and Vineyards welcomes and encourages visitors to walk among the vines and taste wines

Cannabis stinks is covered in ugly plastic and is required to have 24 hour guards with impenetrable security fences and security cameras. It is very intimidating and threatens to eliminate all the good will that the wine industry has created.

The fact that these proposed cannabis projects are providing screening along public corridors is self evident that they are ugly and threatening

Wine grapes and many other agricultural practices require inputs. For wine grapes it is mildew that is our most fearsome foe. Wine grapes would simply not exist without the ability to combat this foe with organic or traditional materials

Material migration is real. Even when strictly following protocol and regulations materials are part of the system. When the wind blows these materials in amounts only detected by the cannabis industry can migrate. We are all now living in fear of a lawsuit.

Our vineyards already have congruent property lines with cannabis growers . We share a property line that is congruent with 132 acres of cannabis . The county justifies this by thinking it is 2 or 3 separate entities though it is obviously operated by the same outfit. This outfit also shares a boarder with one of the oldest county parks the beautiful 36 acre Santa Rosa park. I wonder what the good family that donated this land would think of Santa Barbara's planners today. Looking at the proposed projects our vineyards will be soon surrounded. I am not anti cannabis but there needs to be acreage limits per parcel similar to every other county. Lets protect existing agricultural interests until these conflicts can be worked out. The threatening security requirements need to be revised and or if required not allowed in areas with conflicting interests. The counties anticipated revenue is a not reliable. The track and trace program is a joke it is not being

implemented. This leaves revenue subject to black market sales which in turn puts the hole community in jeopardy. Lets figure out how to mitigate these issues before overwhelming our beautiful valley.

<u>Please read the below into the record at Tuesday's Board of Supervisors hearing, as I am unable to attend or call in.</u>

While COVID-19 was a threat we never saw coming, we have been sounding the alarms about the threat that unchecked cannabis planting presents to wine and other agricultural industries for years. PLEASE listen to existing agricultural businesses and continue this appeal until the Planning Commission can make recommendations to fix the existing cannabis ordinance. I'm not anti-cannabis, but I am extremely concerned that this project will move forward under an ordinance which clearly needs massive revisions.

There are millions of acres in Santa Barbara County where cannabis could grow far from vineyards. However, that's not where the cannabis folks want to be - they want to be right next to vineyards. Why? I believe these operators want to piggyback off the decades of marketing our wine industry has done about our AVAs - the very thing that defines the quality of our wines. They want to market their cannabis as "grown right next to world class vineyards in notable AVAs" so they can charge more for their product without worrying if they are destroying our existing industry in the process.

It's not just vineyards with concerns: Grower associations from strawberries, to vegetable row crops, to citrus and avocado have concluded the current cannabis ordinance is not compatible with legacy agriculture.

Further, I'm worried that tourists who flock to our wine country will choose other destinations when they realize that skunk-like odors wafting from nearby cannabis farms are ruining their ability to taste and smell our wines.

Please do not approve this project.

Dear Honorable Supervisors:

I, with my family, own two properties on Drum Canyon Road in the Santa Rita Hills, including a home and vineyard. We are in the planning stages of building a winery and tasting room on one of the parcels and now have serious concerns about the viability of our plans given the concentration of large cannabis cultivation projects in the Sta. Rita Valley AVA. I am writing in support of the appeal of Blair Pence of the Santa Rita Valley Ag cannabis project and to support the Planning Commission's denial of the Santa Barbara West Coast Farms Project.

My properties, along with my neighbors, are not a designated EDRN but are a small cluster of homes and tasting rooms that will be impacted by large cultivation projects along Drum Canyon Road. Similar to Mr. Pence, our existing agricultural operations are surrounded on all sides by 6 pending cannabis cultivation operations totaling 240 acres (one project is pending for a massive 147 acres, and another for 70 acres). The cultivation sites occupy the majority of the parcel and are not adequately set back, if at all, from the property lines. These large-scale projects will in the aggregate have serious impacts to existing agriculture and tasting rooms that are immediately adjacent. At least one major cultivation site has already put up hoops, 15-foot-tall fencing, and video cameras along the small road we use to reach our home.

I am specifically concerned with potential liability associated with pesticide drift despite legal applications of such pesticides and terpene contamination of winegrapes. The Board must start denying projects adjacent to existing agriculture to avoid these inherent land use conflicts. There is substantial evidence that this conflict is real, continuing, and there is not yet a viable solution. If the Board does not deny these projects, the Board must at least reduce the acreage of these projects and require significant setbacks from adjacent parcels. These measures are the simplest solution to mitigate the impacts of these projects on existing agriculture.

With what I understand to be 23 pending cannabis projects in the Sta. Rita Hills AVA, I remain extremely concerned about the odor impacts to tasting rooms in this area. The majority of the County's wineries are located in the Sta. Rita Hills AVA, and all wineries are sustained by tasting room visitors. Given our temperate climate, tasting rooms in Santa Barbara County are uniquely situated to be able to serve visitors outdoors during most of the year. Even just one or two weeks of cannabis odors during harvest periods are sufficient to drive away visitors, who we expect would not return. This is lost revenue for our business, the County, and renders the wine industry inviable. I operate in a highly competitive industry and am fighting for the same tourist dollars as wineries in other counties who have ensured tasting rooms will not be inundated with cannabis odors. The Board can simply require odor control for Santa Rita Valley Ag to address this issue — as more projects in this area come before your Board, you cannot continue to ignore the clear need for odor abatement to mitigate the cumulative odor impacts and avoid irreparable harm to our wine industry.

I urge the Board to immediately address these significant impacts as they relate to the Santa Barbara West Coast Farms and Santa Rita Valley Ag projects. These two projects alone total 87 acres of outdoor cultivation and the cumulative odor impacts to adjacent parcels will be significant. My business and my family's future in the wine industry are dependent on what happens now with large-scale grow proposals, and we hope for your help in preventing an end to our future.

PLEASE READ MY COMMENTS BELOW INTO THE PUBLIC RECORD.

Santa Barbara Supervisors:

I am writing to urge you to uphold the SB County Planning Commission's denial of the revised Santa Barbara West Coast Farms project for the following reasons:

- This project is located within the scope of the Santa Ynez Valley Community Plan and at both the western entrance to the SYV and the eastern entrance to the Santa Rita AVA.
- Besides negative visual impact on both, the proposed project is within the thermal inversion zone that holds odors and fire particles at ground level.
- This project is one of many cannabis applications submitted in this immediate vicinity that would create an *industrial cannabis corridor* west of Buellton that is <u>incompatible</u> with the SYV Community Plan.
- Clustering commercial cannabis operations at the gateway to the SYV <u>was not</u> covered by the PEIR and it is inconsistent with the CEQA premise that "It is necessary to provide a high-quality environment that at all times is healthful and pleasing to the senses and intellect of man." (Public Resources Code 210000.



Your Planning Commission did what you asked. Their **thoughtful deliberation led to denial of this project**. Their findings concluded:

- This project is the western entrance SYValley (within the SYV Community Plan) and the eastern entrance to the Santa Rita AVA. It will have a negative impact to visual resources on both.
- This valley is formed by two mountain ranges and experiences thermal inversions that hold odors and fine particles at ground level.
- This is one of many cannabis applications in the immediate vicinity. creating an **Industrial Cannabis Corridor** to the west of Buellton that will be inconsistent with the Santa Ynez Community Plan and the CEQA premise that "It is necessary to provide a high-quality environment that at all times is healthful and pleasing to the senses and intellect of man."
- Commissioner Parke stated in the Santa Rita Ag hearing, the PEIR did not cover clustering around the gateway to the SYV.
- This project will impact agricultural activities on non-cannabis farms, specifically application of standard materials (e.g. sprays to control pests and mildew) and standard practices (such as plowing that kicks up dust). This impacts the long term viability of non-cannabis farming which is protected in the Ag Element.

I urge you to affirm the Planning Commission's denial of the Santa Barbara West Coast Farms Project.
