PROJECT TITLE: Ashely Road Temporary Bridge Replacement and Relocation

PROJECT DESCRIPTION: The project consists of two separate actions to allow for the replacement of the temporary bridge on Ashley Road (site # 1E19) with a permanent structure in the unincorporated area of Montecito. The exiting temporary railcar bridge on Ashly road will be removed. A new pre-cast bridge will clear-span the creek channel, the project will include repair of the roadside drainage that was destroyed with the original bridge at the project location.

After the removal of the temporary railcar bridge on Ashley road over Cold Springs Creek the temporary bridge will be relocated and placed at the destroyed low water crossing on East Mountain Drive over Cold Spring Creek approximately 0.7 miles north (site # 1E02). The temporary bridge will clear span the creek and not require work in jurisdictional areas.

This exemption considers all further administrative activities for this project such as Award of Contract and the Statement of Final Quantities.
