That the Board of Supervisors:

- a) Accept a donation of \$14,000 from the Santa Barbara Alliance for Community Transformation, a 501(c) (3) organization, for the Sheriff's Office Human Trafficking Task Force.:
- b) Approve Budget Revision Request BJE-0006887 Increase appropriations of \$14,000 in Sheriff General Fund for restricted Donations fund balance (\$14,000) funded by unanticipated revenue from Miscellaneous Revenue Donations (\$14,000); and
- c) Find that the proposed action does not constitute a "project" under the California Environmental Quality Act because it is within the exception provided by 14 CCR 15378(b)(4) for "[t]he creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment."

Summary Text:

The Santa Barbara Alliance for Community Transformation, a 501(c) (3) organization, has recently approved a donation of funding to the Sheriff's Office. The Santa Barbara Alliance for Community Transformation has identified the Sheriff's Office Human Trafficking Task force, as the desired recipient of this donation. The value of the donation totals \$14,000 and will be used for the purchase of two (2) Cellebrite licenses and dongles for human trafficking investigations.

Background:

County Policy D4.1 requires that departments submit donation requests to the Board of Supervisors. The Santa Barbara Alliance for Community Transformation, a 501(c)3 non-profit, fund-raising organization, has donated the \$14,000 in an effort to assist the Sheriff's Office Human Trafficking Task Force with investigative tools (two Cellebrite licenses and dongles).

The Santa Barbara Alliance for Community Transformation has identified the above detailed items as being needed to improve or enhance the operations of the Sheriff's Office Human Trafficking Task Force and its partners.
