**WHEREAS**, the Board of Supervisors of the County of Santa Barbara may, by resolution, establish services rates and fees for various County agencies and departments;

**WHEREAS**, the Board of Supervisors of the County of Santa Barbara, by resolution established Juvenile Probation Administrative service rates and fees;

**WHEREAS**, the fees established are as follows:

| e. Community Service Work Extension Fee  | \$25.00            |
| f. Failure to Retrieve from Custody Fee  | \$100.00 / day     |
| g. Restitution Surcharge                 | 10% of restitution |

**WHEREAS**, effective January 1, 2018, Senate Bill 190 (SB 190) amended several statutes to remove the authority to assess most fees in the juvenile delinquency system;

**WHEREAS**, SB 190 did not address fees that accrued before January 1, 2018;

**WHEREAS**, it is in the best interest of the county, youth and families involved with the juvenile justice system, and the larger community, that the County repeal all Juvenile Probation Administrative fees including those imposed and accrued before January 1, 2018;

**NOW, THEREFORE, BE IT RESOLVED by** the Board of Supervisors of the County of Santa Barbara, acting as the governing body of the County of Santa Barbara, as follows:

1. A repeal is imposed on the assessment and collection of juvenile probation administrative fees, suspending the assessment and collection of:
  - a. Juvenile Hall/LPBC Daily Rate;
  - b. Record Sealing Fee;
  - c. Community Service Work Enrollment Fee;
  - d. Community Service Work Transfer Fee;
  - e. Community Service Work Extension Fee;
  - f. Failure to Retrieve from Custody Fee;
  - g. Restitution Surcharge

2. The Probation Department Revenue Recovery Unit is authorized to write-off accounts receivable balances for all Juvenile Probation Administration Fees.
