Budget Action: Increase appropriations of \$17,200 in Sheriff General Fund for Capital Assets-Equipment funded by unanticipated revenue Miscellaneous Donations.

Justification: During the initial weeks of the COVID-19 pandemic, hospitals and morgue facilities quickly became overwhelmed. The projected death rate in Santa Barbara County

exceeded the morgue storage capacity in the county, and the Sheriff's Coroner's Bureau sought ways to increase the storage capacity. The California Office of Emergency Services (CalOES) Coroner's Mutual Aid branch notified Coroner's Offices throughout the state of an opportunity to obtain a donation of a refrigerated trailer.

The Sheriff's Office received a donated 53-foot refrigerated trailer from Hub City Terminals, Inc. for use at the Sheriff's Coroner facility.
