**FOURTH AMENDMENT**

**Effective April 1, 2020**

**THIS FOURTH AMENDMENT** to the Master System Agreement for Practice Management System and Electronic Medical Record System entered into by the parties on July 1, 2017 (Agreement), by and between the County of Santa Barbara (MEMBER) and Oregon Community Health Information Network (OCHIN), is effective as of April 1, 2020.

**RECITALS**

**WHEREAS**, the Agreement is effective through March 31, 2020; and

**WHEREAS**, Agreement section 2.2. states, "Upon mutual agreement of the Parties the term may be automatically extended up to three (3) times with each extended term being two (2) years. The Parties agree to review and, if needed, to update this Agreement at any automatic term extension"; and

**WHEREAS**, parties desire to amend the Agreement to extend the term through March 31, 2022 and have reviewed the Agreement for updates; and

**WHEREAS**, this Fourth Amendment incorporates the terms and conditions set forth in the Agreement and all prior amendments.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree to amend the Agreement as follows:

1. The above recitals are deemed true and correct and incorporated herein.
2. **Definitions.** Capitalized terms used in this Fourth Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
3. **Amendments.** The Agreement is amended as follows:  
Section 3.3 is deleted and replaced in its entirety with:

3.3. MAXIMUM AMOUNT: The maximum amount payable under the terms of this agreement, including cost reimbursements, shall be up to but shall not exceed **\$5,360,00** through March 30, 2022.

4. Counterparts. This Fourth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
5. Effectiveness of Agreement. Except as explicitly modified by this Fourth Amendment, all of the terms and provisions of the Agreement and all previous modifications and amendments, if any, are and remain in full force and effect.






