Summary Text:

This item is on the agenda in order to acquire public sewer easements over APNs 129-290-008, 009, 010, 011, 012, and 013 to convey wastewater from these and neighboring parcels as well as from proposed development on APN 129-151-026, also known as Orcutt Community Plan Key Site 3.

Background:

Orcutt Community Plan Key Site 3 is a 146.49 acre parcel located west of and adjacent to US Highway 101 and south of Clark Avenue. The development of Key Site 3 is subject to review by the Planning and Development Department and consists of 125 single family residential housing units and a separate multi-family residential (condominium) development. The proposed tentative map subdivides the property into 138 lots including roadway and open space lots.

The conveyance of wastewater to Laguna County Sanitation District collection system facilities is required. Because the property is not adjacent to any existing sewer systems, an extension from Stillwell Road through private property is necessary. The developer has negotiated the acquisition of a 30' sewer easement from the owners along the south half of Oak Brook Lane, a private road. This action requests that the Board accept the six (6) attached easements.

Performance Measure:

This action will provide the appropriate sewer rights of way to ensure the sewer main is held in ownership by Laguna County Sanitation District.

Fiscal and Facilities Impacts:

There are no fiscal or facility impacts with this action.

Staffing Impacts:

There are no staffing impacts associated with this action.

Special Instructions:

After Board action, direct the Clerk to:

- 1. Execute the acceptance of easement deed for the sewer easements on APNs 129-290-008, 009, 010, 011, 012, and 013.
- 2. Forward the executed easement deeds and certified minute order to Martin Wilder, Laguna County Sanitation District at the North County Public Works Building, 620 West Foster Road in Santa Maria, CA 93455, to record. Recorded copies will be forwarded to the Clerk of the Board for filing.
