I am writing to the county of Santa Barbara regarding the reported retaliation by officials by persons who do not social distance, wear masks, or stay indoors.

I write this as a health professional (medical research, public health, environmental health, and wellness). I will make my case brief.

- 1. According to top medical officials not employed by the federal government epidemiological data on case fatality rates shows that the pandemic is over at the end of this month so any measures to keep people out of work, in their homes, masked up, and away from others are misguided. According to Ioannidis and Levitt (Stanford Univ). state that the numbers indicate an end to the pandemic by August 25 this week.
- 2. State health officials should declare epidemics when there is a clear and present danger to citizens this has not been shown with covid-19. In fact in all other epidemics, closures were 2-4 weeks maximum. This pandemic has been going on for over six months. A clear violation of health policy and constitutional freedoms. County health officials do not have the authority to close businesses indefinately.
- 3. Since there are over 40 studies showing the health effects of masks county officials should be concerned over the legal implications of mandating something that causes harm to persons lung tissue, oxygenation, and body function. It would stand to reason that health and public officials would be sued if any member of public comes down with a pulmonary disease directly related to wearing masks.
- 4. Union workers and others with contracts who are now mandated to wear masks would have grounds to sue based on breach of contract.
- 5. By mandating illegal measures long after the end of the curve, the county is setting itself up for constitutional violations on a number of levels. In order to restore a more normal return to business the country of Santa Barbara should look into the science of reopening based on current information.
- Health clubs and health spas should be open in the fall
- movie theaters, concert halls and open air gathering should be taking place by the end of the year.
- by new years 2021 all businesses should be back to normal with no use of contact tracing or other measures.
- the country should only use reliable blood testing for looking at covid cases, as the PCR testing has a predictive value of just .55 or 50% (a terrible reliability value).

We would hope that the county relies on true scientific information - rather that politics, to shape the course of their actions going forward.
