


Figure 1-US 101 Gaviota Curve Area

I have a concern about the Gaviota Culvert Replacement project proposed by CalTrans. My concern is that during the replacement operations, heavy equipment will probably use the existing adjacent pavement to access the repair area north of US101. Attachment 6 of the CalTrans MMP seems to confirm this. This could result in damage to the pavement.

Description of Historic Pavement

This pavement is the original historic pavement of the US 101 predecessor. It starts near the project north of the freeway and continues for about 0.35 mile just short of the newly revamped curve on US 101. The pavement is in generally good shape, in spite of its age. The original road edgings and a few roadside features still exist. There are still other short segments of the original route south and east of the freeway.

Historic Pavement Use

CalTrans has previous used the western portion of the historic pavement during the construction of the revamped Gaviota Curve. Luckily no major damage occurred.

This same portion is also used by gas and oil pipeline contractors to access an unpaved service road for inspection and service of portions of a high-pressure gas pipeline and the presently inactive Plains oil pipeline. CalTrans may also use this access to maintain a water pipeline serving the Gaviota rest stops. Fortunately, these uses generally do not involve the use of heavy equipment.

Although no formal trails have been established on this State Park land north and east of US101, the historic pavement does serve as a de facto route to connect to an unpaved service road for hikers wishing to get to a viewpoint overlooking the northbound Gaviota rest stop. Foot access to the historic pavement is via the Gaviota Village property.

Suggestions to Avoid Damage

Possible damage could be avoided or minimized if heavy equipment access on the north side of the project could be made from the Gaviota Village (State Park property), east of the project area. Some access via the historic pavement may be required as there seems to be quite a bit of on-site mitigation on each side of the pavement. Can we request that CalTrans take note of the historic pavement and take reasonable care to avoid damage?

Board of Supervisors Hearing on GCC's appeal of Caltrans Culvert Project 1 September 2020

I am writing out of concern for the preservation of the Gaviota Coast at the site of the proposed Caltrans culvert replacement off Highway 101 in the Canada del Barro drainage on park land just east of Gaviota State Beach Park.

The Caltrans Development Plan lacks sufficient background work to adequately address the environmental impact of the proposed project. The portion of Highway 101 where the Project is proposed has been studied by Dr. Stratton of UCSB's Cheadle Center for Biodiversity & Ecological Restoration and Dr. Shilling of UC Davis. Both have reported large wildlife populations, that require thorough consideration, in this region of the North Coast.

Caltrans' own Wildlife Crossing Guidance Manual identifies culvert replacements as an "opportunity to enhance existing rates of crossing and decrease rates of vehicle-animal collisions if the new culverts are larger than the existing culverts and include wildlife ledges, fencing, and vegetation to enhance their use". For the Gaviota Culvert, Caltrans incorrectly maintains that there are no wildlife corridors to consider. Caltrans has declined to accommodate wildlife crossing in its project, in an area with an extraordinary level of wildlife-vehicle conflicts, per Dr. Stratton & Dr. Shilling.

These expert studies confirm:

- 1. the need to reevaluate the Project's impacts to wildlife, including whether the proposed habitat restoration activities will attract wildlife and increase wildlife-vehicle collisions.
- 2. the culvert must be redesigned to accommodate wildlife passage as described in Caltrans' own Wildlife Crossings Guidance Manual.

In addition, the land under the control of State Parks must not be transferred to Caltrans without offsetting the mitigation such as provision of a California Coastal Trail segment. The Project cannot be approved as proposed due to conflicts with the Gaviota Coast Plan including recreation policies requiring that existing and proposed trails be preserved and provided for in discretionary development projects, and policies protecting sensitive wildlife and wildlife corridors.

I urge the Board of Supervisors to uphold the appeal of the Gaviota Coast Conservacy (GCC) and the Coastal Ranches Conservacy (CRC). I urge the Board of Supervisors to require extensive environmental review. I urge the Board of Supervisors to support Project modifications to accommodate wildlife passage under Highway 101 and passive recreational uses.

The Project cannot be approved as proposed due to conflicts with the Gaviota Coast Plan including recreation policies requiring that existing and proposed trails be preserved and provided for in discretionary development projects, and policies protecting sensitive wildlife and wildlife corridors.

The GCC and CRC appeals raise serious flaws in the Project design and environmental review, and should be granted.

Thank you for your consideration in protecting this beautiful stretch of the Gaviota Coast, the wildlife that inhabits the area, and the Gaviota Village land for generations to come.
