The complexities of each neighborhood, zone and site deserve thoughtful review based on the design overlays, view corridors and adjacent development, while the process for approval is laid out clearly for applicants and neighbors can feel heard. I've cultivated my ability to review the critical elements of a design quickly and identify what needs to be addressed in early phases of design and what can be developed further along in the process.
