Please endorse Prop 15 tomorrow when you convene. Prop 15 will ...

- Close property tax loopholes that benefit wealthy corporations by requiring reassessment of commercial and industrial properties ONLY. Right now, they are only reassessed if the physical property changes ownership. Most corporations have held their property for a long time longer than most homeowners or small businesses do and if they do sell, they commonly sell the company as opposed to physical property.
- Exempts homeowners, renters, small businesses, and agriculture. Also exempts commercial and industrial properties valued at under \$3 million
- Reclaim billions of dollars that will go directly to our schools and local community services throughout the state. In Santa Barbara County info on what can be reclaimed can be found <u>here</u>. But basically this is the summary:
  - oSanta Barbara County General Fund: around \$30 million this is around the same as our cannabis tax is generating and we have already seen how that has helped us save services during this COVID recession. We don't know how long this will last and this money will be CRITICAL to preserving services
  - o Santa Barbara City: between \$5 and 6 million
  - oGoleta City: a little over \$1 million
  - o Carp City: around \$500,000
  - o Santa Maria City: between \$3 and 4 million
  - o Around \$43.5 million for Santa Barbara County schools and an additional \$10 million for our community colleges

This money is going to be absolutely critical to all cities, special districts, and school districts to prevent cuts in the difficult years to come.

When we care for families, we are caring for our community. This proposition enables us to reclaim funding that we need.

I believe building owners whose properties are worth more than \$3 million should certainly be taxed on that value; the original intent of the tax exemption was to support and assist people - individuals and families - whose wages and income weren't increasing at the rate of their properties. Property ownership has become a business in itself, and the incorporated groups that own and deal in property ownership are allowed to skirt the obligations of that business by taking advantage of a law that wasn't written for them. I've heard concerns that the building owners will pass along the increased cost to the small businesses that rent from them. Below is my public comment for today's Board of Supervisors meeting.

Thank you,

I'm here to extend my gratitude to the Public Health Department for the health officer order issued this past Friday.

This order is an urgently needed step to prevent any further farmworker deaths from COVID-19 in Santa Barbara County. We applaud Public Health, and in particular the leadership of Dr. Do-Reynoso in protecting the health of our essential workers who have been hard-hit by this pandemic.

The H-2A program presents unique challenges because of the shared housing and transportation of workers, as well as their vulnerability and isolation from crucial safety information as they are seasonal workers here in the country for only a short time.

Regular screening is a critical step to keep a case among one worker from developing into a full-blown outbreak amongst workers in close quarters. It will ensure H-2A workers who contract COVID-19 are isolated and taken care of, it will protect the rest of the workforce.

Now that Public Health has issued this health order, we'd like to help ensure that it is enforced. The best way to do this is to create an accessible channel of communication for farmworkers to report violations directly to the county. We'd like to request that the county create a farmworker hotline housed under Public Health where farmworkers can call to notify the department when COVID safety guidelines are not being followed at their workplace.

Lastly, CAUSE would also like to voice support for the Prop 15 resolution.

Prop 15 is critical for turning back the tide on generations of disinvestment in public education since over 40 years ago when we had some of the best funded schools in the nation.

Our school systems are often asked to fix the deeply rooted economic and racial inequality in our communities with very little resources. To put all students on a path to success, we need well-funded, world-class schools.

We have the money in our community for everything our students need. This community and state have incredible wealth, but some of our largest corporate landowners are exploiting massive tax breaks that were intended to keep fixed-income seniors in their homes.

We ask that you put our School and Communities First and please support passing a resolution in support of Proposition 15.
