Justification: This Budget Revision request will amend the FY 2020-21 adopted budget for the appropriation transfers and unanticipated revenue transactions necessary to fund and

process the FY 2019-20 Voluntary Rate Range Program (VRRP) through a partnership with CenCal Health. The VRRP will allow for the leveraging of local dollars for matching federal financial participation FFP) through the State Department of Health Care Services (DHCS) and will be performed as two separate sets of transfers called Intergovernmental transfers (IGTs). The first set of transfers (IGT#1) is anticipated to occur in FY 20-21 and the steps and estimated dollars are as follows: 1) A transfer of \$1,640,000 in local dollars with an assessed 20% DHCS fee of \$300,000 is anticipated for April 2021; 2) Funds will be matched with FFP and will be returned to the PHD by CenCal Health (\$4,620,000); 3) PHD will transfer the original \$1,640,000 to the general fund and will designate the rest (\$2,980,000) to be used on community

health and communicable disease response programs as determined.
