Thank you for taking the time to read and heed my comments. The attached is regarding Item Number 1 (Mask order). I have a lot of questions that could not be stated in 250 words or less. I hope they can be addressed. I will watch the meeting online.

Thank you, Laurel Ward 93455 Many doctors, including Fauci and Ansorg (in this Order), acknowledge that PROPERLY FITTED MEDICAL MASKS are the only ones that "help." Dear County Supervisors,

Thank you for your leadership in helping our community navigate the changed landscape wrought by the COVID-19 pandemic. Specifically, I would like to express my appreciation for the county order to require face masks in specific public places, with the intent to slow the spread of COVID-19. It may seem onerous to have to wear a face covering - I myself do not find them very comfortable - but it is something we all need to do for each other. If we want to continue to open the county safely, we must be willing to protect those who are working in the businesses we visit, most of whom are wearing cloth or surgical masks, which would not prevent them from getting COVID-19 from a person who is asymptomatic or pre-symptomatic and not wearing a face covering.

It appears that many fellow Santa Barbarans are willing to sacrifice a little of their personal comfort to protect each other. But having a public order that relies upon guidance from the federal Centers for Disease Control and Prevention and multiple scientific studies is <u>critical</u> to keeping us all on the same page when we are out in public. I have three children who are apparently exempt from the mask order (twins who are 6 and an older one who is 9), but they wear their hand-sewn cloth masks whenever we have to go into a store. They don't always enjoy wearing their masks, but they can grasp the value of doing so, for the public good.

Until we have a better way to control the spread of COVID-19, requiring face coverings should remain part and parcel of the public health toolkit we use to keep our residents safe.
