

Santa Barbara County COVID-19 By The Numbers


CUMULATIVE CASE STATUS REPORTED AS OF TODAY


7-DAY ROLLING SUM OF NEW CASES BY AREA



ANTICIPATED CDPH Monitoring Status: 9/29



7-Day Average Adjusted* Case Rate per 100,000 Community Residents






Santa Barbara County, 7-Day Average Case Rate per 100,000 Community Residents





SBC Testing Positivity


7-day Average Community Test Positivity

Equity Metrics: DRAFT

- Ensure test positivity rates in county's most disadvantaged neighborhoods do not significantly lag behind overall county test positivity rate
- Announcement on 9/29
- Effective 10/6
- >To move to less restrictive tiers:
 - 1. Overall county case rate
 - 2. Overall county testing positivity rate
 - 3. Lowest Quartile Test Positivity Rate Must Meet Specified Threshold for Less Restrictive Tier

New Legislation Related To COVID-19

Senate Bill 1159 - Workers' Compensation

• Assembly Bill 685 – COVID-19 Employee Notifications and Reporting



New Legislation – SB1159: Workers' Compensation

Effective Immediately:

- Creates a rebuttable presumption of an industrial injury or illness for certain categories of workers.
 - Focus is primarily certain personnel in the fields of firefighting, law enforcement, emergency medical services, acute psychiatric care, home health care, and in-home supportive services.
 - For all other employees, it may apply to an employee who tests positive within 14 days after an "outbreak" at the worksite.
- Imposes reporting requirements on employers to Workers' Compensation Administrators within three (3) work days for purposes of "outbreak" presumption.



Effective date January 1, 2021:

- Employee Notification: Requires employers to provide 24 hour written notice and instructions to all employees and to employers of subcontracted employees at a worksite if exposed to COVID-19.
- Cal/OSHA Authority: Enhances ability to enforce health and safety standards to prevent workplace exposure and spread of COVID-19.
- **State Reporting**: Requires employers to report a workplace COVID-19 positive test, diagnosis, order to quarantine, or death that could be COVID-19 related to Cal/OSHA and the State Department of Public Health (CDPH).
