Hello! My name is Lizzy Iconomopulos and I am a 4th year undergraduate student at UCSB. I would like to submit a public forum comment to be considered at the Urgency Ordinance in Support of Administrative Fines in Isla Vista.

This is my comment:

I am in full support of administrative fines for large gatherings of individuals in Isla Vista who do not live together such as: house parties, fraternity and sorority gatherings and parties, and religious ceremony gatherings. These types of gatherings put the lives of many people in this community at risk. Social and religious gatherings can and have been happening VIRTUALLY with much success. People who continue to gather in Isla Vista in large numbers for religious purposes or for social purposes are putting their selfish desires above the humanity, safety, and basic needs of other members of this community. Humans have the capacity for empathy, and this ordinance is a positive push towards creating a community that is empathetic and non-sibi (not for self).

I work as a member of the UCSB CARE (Campus Advocacy, Education, & Resources) office and I volunteer with Food Not Bombs-Isla Vista. As an employee of CARE, I come into contact with sexual assault survivors often. Since the start of this pandemic, we have heard that some survivors are fearful to seek support and resources after experiencing an interpersonal violence at an illegally-held party for fear of retaliation, criminalization, or stigmatization. It is very important that if administrative fines are imposed in Isla Vista for large gatherings, this ordinance is not used to intimidate or discourage survivors from accessing resources or making reports. Thus, any person who discloses that they have experienced sexual harassment or assault at a large gathering that would be "illegal" under this ordinance should have immunity from these fines in order to limit the obstacles to reporting or accessing resources for survivors. As a member of the volunteer org FNB-IV, I make and serve meals to the houseless community living in Isla Vista at least once per week. While these folks do congregate without masks, any fine against them would be extremely harmful. They already face policing, criminalization, discrimination, and outright hatred from much of the community. They often only congregate amongst themselves, keep to themselves, and move between the three parks that are occupied by encampments (Anisqu'oyo, Sueno Orchard, Camino Corto). Any fine on folks living in these parks would not only make their lives more difficult, it would have very little effect. These folks have no other place to go, so fining them will only limit their ability to pay for basic needs such as food, water, and laundry. Due to mental illness and a huge lack of resources, some of these folks don't believe in or cannot grasp the reality of the coronavirus. Therefore, I believe this ordinance should include two special exemptions: 1. Any person coming forward to disclose an experience with sexual misconduct that occurred at a large gathering should not be fined (in order to limit obstacles to accessing resources); and 2. Houseless folks living in Isla Vista should not be fined for congregating in the parks (because they have no where else to go at this point in time and how do you expect to collect fines from people with extremely limited resources to begin with).

I hope you are familiar with articles such as https://www.npr.org/2020/08/31/907756835/preventing-college-parties-shame-and-blame-dont-work-but-beer-pong-outside-might, which states: "If the success of your plan relies on 18- to 24-year-olds being responsible, then maybe it's not a very good plan."

UCSB should have established testing, they should have communicated with students, including those not living on campus, and they should have established themselves as leaders in the field. Instead, they want the county to enforce what was 100% their responsibility. They still DO NOT have a portal to communicate spread of Covid in their community (Grade=F for NO DATA).

Students still can not get tests locally that come back within 24 hours. UCSB FINALLY set up testing for students living and visiting campus, but the rest of the students are on their own. Many are driving to Ventura, realizing that test results that come back 3-4 days later are useless in terms of stopping spread.

It is simply ridiculous, and potentially dangerous, to turn to punitive measures. It is much preferable that students are partying outdoors, rather than hiding indoors to avoid fines.

I implore you not to overreach and take responsibility for UCSB's failed Covid readiness.
